***Dance Exposure Procedures related to COVID19**

1. If your child is not feeling well**DO NOT SEND THEM.**
2. All Students must wear a mask at all times. This means entering and exiting Parking Lot as well. Please make sure your child has a mask on before exiting the vehicle.
3. All students must leave their belongings on the Porch. No exceptions!
4. No Parents will be allowed to enter the lobby except for the age 3-4 Classes. Those classes will allow one guardian to assist the child into class or into the bathroom. This means **DROP OFF ONLY** for all the other classes.
5. Absolutely No Siblings entering the building unless they are taking class at that specific time.
6. The majority of classes will be held in Studio A. Those students will enter and exit through the Garage Door Only.
7. Any classes or Private Lessons in Studio B will enter and exit through the lobby door. Please keep a 6-foot distance in the Lobby.
8. We will have extra hand sanitizer through out the studio. Please try to have you child bring their own as well.
9. There is a 15 min block of time between all classes. The teachers will wipe down the bars and door handles as well as Lysol all classrooms.
10. Each teacher will go over the instructions on use of bathrooms and how to keep it sanitized for the next person. We would expect the parents of young children to make sure they Lysol the bathroom after use as well.

This is all new to us as it is to you. Please make sure each family member follows all procedures. If a teacher feels as though a child is not well, that child will be sent home immediately. If your child or anyone in the family has been tested positive for COVID or is exposed, please follow all CDC measures and contact us immediately. Any child not following these procedures will be removed from the class indefinitely without reimbursement. We want everyone Happy, Healthy and Safe.

DANCE EXPOSURE II will not refund payments for missed classes, dropped lessons, inclement weather and emergency closings. Children may make up missed days in other regularly scheduled classes. The studio follows Hopewell School Calendar for school closings on major holidays. We will be closed for business on these days unless notified otherwise.
